1. Unsold tickets will become the property of the Billings Firefighters Local 521 – Benevolent Fund and will not be eligible for drawing.
2. You need not be present to win and all winners will be notified by mail and phone. A winner will be drawn for each day in the month of September, 2023.
3. Prizes must be claimed by October 31, 2023.
4. Prizes not claimed will be forfeited to the Billings Firefighters Local 521 – Benevolent Fund
5. All Federal, State and Local laws and regulations apply.
6. A maximum of 3000 tickets will be sold. 900 tickets must be purchased by August 1, 2023, for the 'Gun-A-Day Raffle' to take place. In the event less than 900 tickets are sold, all monies will be returned by mail. Ticket sales at Scheels will end Sept. 15, 2023. Tickets purchased after Aug. 31 will only be eligible for the remaining days of the drawing.
7. It is the responsibility of the purchaser to inform the Billings Firefighters Local 521 – Benevolent Fund of address and phone number changes by mail. Notification shall be sent to BFBF 3031 Grand Ave. Suite 100 PMB Billings, MT 59101.
8. Caliber selection may delay receipt of firearm
9. Winners **MUST** pass background check prior to receiving firearm. Purchasers name on ticket must be the same individual receiving the firearm. Proper identification is required to claim prizes. Winner must present a valid government issued photo ID with their actual physical address.
10. Name on the ticket cannot be changed after purchase.
11. When paying by check, include driver's license number, phone number and address with check. Ticket will be removed from the drawing for checks returned due to insufficient funds.
12. Purchaser of ticket must be 18 years at the time of purchase, or 21 to claim a handgun. \*
13. **Ticket sales are limited to residents of Montana or its' contiguous states (North Dakota, South Dakota, Wyoming and Idaho).**
14. Prize winners shall receive their firearm from Scheels All Sports, 1125 Shiloh Crossing, Billings, MT or store credit for value of prize & Shiloh Rifle, Big Timber, MT. The Shiloh rifle (Grand Prize drawn Sept. 30) must be picked-up at Big Timber, MT. Winners are responsible for costs incurred through delivery (out of town).
15. Each ticket is eligible for every prize. A ticket drawn will be reentered for all remaining drawings.
16. Gun values listed are as of January 1, 2023. The prize awarded will be the actual cost of that firearm or monetary equivalent for in store credit at Scheels not including Shiloh Sharps.
17. Grand Prize winner (Shiloh Sharps rifle) cannot exchange rifle for store credit at Scheels. Grand Prize winner must travel to Shiloh Sharps (Big Timber, MT) to receive Grand Prize.
